Information regarding deduction of Income tax at source from payment of Dividend for the financial year 2022-23

Dear Shareholder(s)

We are pleased to inform you that the Board of Directors at its meeting held on May 26, 2023, has recommended a Dividend of Rs. 8/- per Equity Share of Rs. 10/- each for the financial year 2022-23, subject to the approval of the shareholders at the 36th Annual General Meeting (AGM) scheduled to be held on Friday, September 29, 2023.

The Company has fixed Friday, September 22, 2023 as the "Cutoff date" for determining the names of the members eligible for dividend on equity shares, if approved.

If the dividend, as recommended by the Board of Directors, is approved at the AGM, payment of such dividend subject to deduction of tax at source will be made within a period of 30 days from the date of declaration as under:

- a. To all Beneficial Owners in respect of shares held in dematerialized form as per the data as may be made available by the National Securities Depository Limited ("NSDL") and the Central Depository Services (India) Limited ("CDSL"), collectively "Depositories", as on Cutoff date;
- b. To all those shareholders holding shares in physical form, as per the details provided to the Company by the share transfer agent of the Company, KFin Technologies Limited. ("KFin"), as on cutoff date.

Accordingly, you are requested to ensure that the below details, as applicable to you, are submitted and/or updated with KFin/ in your Demat account(s) maintained with the Depository participant(s):

- i. Valid Permanent Account Number (PAN);
- ii. Residential status as per the Income-tax Act, 1961 ('the Act'), i.e., Resident or Non-Resident for FY 2023-24 (i.e., for the period April 01, 2023 to March 01, 2024);
- iii. Category of the Shareholder, viz. Mutual Fund, Insurance Company, Alternate Investment Fund (AIF) Category I, II or III, Government (Central/ State Government), Foreign Portfolio Investor (FPI)/Foreign Institutional Investor (FII), Foreign Company, Individual (Resident or Non-Resident), Hindu Undivided Family (HUF), Firm, Limited Liability Partnership (LLP), Association of Persons (AOP), Body of Individuals (BOI) or Artificial Juridical Person, Trust, Domestic Company, etc.;
- iv. Email Address;
- v. Mobile number;

- vi. Bank account details; and
- vii. Address with PIN code / Zip code with country name

Following additional documents are to be submitted by the shareholders holding shares in physical form along with Form ISR 1:

- Scanned copy of cancelled cheque leaf of the above-mentioned bank account (In case, the cancelled cheque leaf does not bear your name, please attach a copy of the bank passbook statement, duly self-attested); and
- Self-attested copy of your PAN card.

This will facilitate receipt of dividend directly in your bank account

This communication is being made to the shareholders of Alphageo (India) Limited ("the Company") regarding deduction of income tax while payment of their dividend as per relevant provisions of Income Tax Act, 1961.

Dividend income is taxable in the hands of shareholders and the Company is required to deduct tax at source at the prescribed rates from dividend paid to shareholders. The shareholders are requested to refer to the Income Tax Act, 1961 for the prescribed tax rates applicable to them.

The Primary shareholder can request the Company to provide the credit of Tax Deducted at source on the dividend pay-outs by the Company, separately to the joint shareholders (beneficiary shareholder) of the said shares by submitting the declaration as per Rule 37BA of the Income Tax Rules, 1962. This declaration shall be submitted with the Company on or before September 22, 2023 by 5.00 p.m. Any declarations as per Rule 37BA submitted after this date will not be considered. The information of the payee and tax deducted thereon will be submitted to income tax department as per the details of primary shareholder provided by the Depositories / RTA or as per declarations under Rule 37BA received till September 22, 2023.

If shareholder is classified as "specified person" as per the provisions of section 206AB, tax will be deducted at the rate higher of the following:

- I. Twice the rate specified in the relevant provision of the Income-tax Act; or
- II. Twice the rate or rates in force; or
- III. The rate of 5%.

The 'specified person' means a person who has:

- i. not furnished return of income for the assessment year relevant to the previous year immediately preceding the financial year in which tax is required to be deducted, for which the time limit for furnishing the return of income under section 139(1) of the Income Tax Act, 1961 has expired; and
- ii. subjected to tax deduction/collection at source in aggregate amounting to ₹ 50,000/- or more in the abovesaid previous year

For this purpose, the Company will be relying on the information verified by the utility provided and available on the Income Tax website.

The rate of deduction of tax from dividend would vary depending on the residential status of the shareholder under the income tax act, as informed by the Depository Participant / KFin Technologies Limited (KFintech), the Registrar and Share Transfer Agents (RTA) of the Company.

The company will not entertain directly any request for change in the residential status of the shareholder. Such requests for change in residential status shall be submitted with respective Depository Participant (DP) / RTA along with requisite documents. It is reiterated that the residential status as informed by the DP/RTA as per their records as on the Cutoff date will be the final for determination of rate of tax to be deducted from payment of dividend to the respective shareholder.

As per Section 139AA of the Act, every person who has been allotted a PAN and who is eligible to obtain Aadhaar, shall be required to link the PAN with Aadhaar. In case of failure to comply to this, the PAN allotted shall be deemed to be invalid/inoperative and tax shall be deducted at the rate of 20% as per the provisions of section 206AA of the Act.

C. NOTES

- i. The Company will issue soft copy of the TDS certificate to its shareholders through e-mail registered with KFintech post payment of the income tax deducted and submission of respective return with income tax department. Shareholders will be able to download Form 26AS from the Income Tax Department's website https://incometaxindiaefiling.gov.in.
- ii. The aforesaid documents such as Form 15G/ 15H, documents under sections 196, 197A, FPI Registration Certificate, Tax Residency Certificate, Lower Tax certificate etc. can be uploaded by using the link https://ris.kfintech.com/form15/ on or before September 22, 2023 (5.00 p.m.) to enable the Company to determine the appropriate TDS / withholding tax rate applicable. Any communication on the tax determination/deduction received after the September 22, 2023 will not be considered. - iii. Application of TDS rate is subject to necessary verification by the Company of the details of the shareholder as available in Register of Members as on the Cutoff date and other documents available with the Company/ KFintech.
- iv. Shareholders holding Equity shares under multiple accounts under different status / category, under single PAN, may note that, higher of the tax as applicable to the status in which shares held under a PAN will be considered on their entire holding in different accounts

- v. In case TDS is deducted at a higher rate, an option is still available with the shareholder to file the return of income and claim an appropriate refund. Tax deducted by the Company is final and no claim shall lie against the Company for tax deducted at higher rate, for any reason, whatsoever.
- vi. No TDS will be deducted in case of resident individual shareholders who furnish their PAN details and whose dividend does not exceed Rs. 5,000/-. However, where the PAN is not updated in Company/ KFintech/ Depository Participant records or in case of an invalid PAN, the Company willdeduct TDS u/s 194 without considering the exemption limit of Rs 5,000/-.
- vii. All the shareholders are requested to update their PAN with their Depository Participant (if shares are held in electronic form) and Company / KFintech (if shares are held in physical form) against all their folio holdings on or before Cutoff date i.e., September 22, 2023.
- viii. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided by the shareholder, such shareholder will be responsible to indemnify the Company and, provide the Company with all information / documents and co-operation in any appellate proceedings.
- ix. This Communication is not exhaustive and does not purport to be a complete analysis or listing of all potential tax consequences in the matter of dividend payment. Shareholders should consult their tax advisors for requisite action to be taken by them.
